The Case for Restorative Justice



Restorative justice is based on a theory of justice that focuses on crime and wrong-doing as acted against the individual or community rather than the state. It emphasizes repairing harm caused or revealed by criminal behavior. In RJ processes, the person who has done harm

(offender) and the person who has been harmed (victim) take an active role. The victim may receive an apology, direct reparation or indirect action to restore or fix the damage.

For our December meeting, Patricia LaTaille, Executive Director of Full Circle Restorative Justice, will tell us how RJ is implemented in the 11th Judicial District, including Chaffee, Fremont and Saguache counties.

Ms. LaTaille has been involved with FCRJ since its inception, and has served as a board member and president. She has over 20 years of experience in working with at-risk youth and has founded and managed a number of successful youth programs. She trains FCRJ volunteers in Non-Violent Communication and leads weekly Compassionate Communication study groups for the community and in the Chaffee County Detention Facility. Source: FCRJ.

Salida Chooses LWVCC to Hold Forum on Home Rule

At the request of City Administrator Dara MacDonald, LWVCC is sponsoring a forum where Salida citizens can learn about the ballot question of home rule for their city and about electing commissioners who would draft a home rule charter. The forum will be held on Wednesday, December 12 from 7 to 9 p.m., in the City Council Chambers, Touber Building, 448 East 1st Street.

Jacqueline Sobczak, Voters Service committee, is moderating the forum. Elizabeth Richie organized the event with the assistance of Marjie Gray, Voter Services Chair; additional members are assisting.

The forum starts with speakers discussing the merits and problems of having a home rule city. After the discussion, candidates who are vying for the 11 positions on the charter commission will answer questions about their qualifications and about Salida becoming a home rule city. The questions were submitted by LWVCC and included in each candidate's invitation letter.

Two items are on the ballot:

- 1. Shall the City of Salida form a home rule charter commission?
- 2. Select up to 11 of the following candidates to serve on the charter commission.

Candidates for the Home Rule Charter Commission are as follows: John Merrell Bergin, Cheryl Brown-Kovacic, Billy E. Carlisle, Lisa Connell, Vern Davis, Monika Griesenbeck, Melodee Hallett, Michael Harvey, Jane Jolley, Martin Jolley, Debra Juchem, Lisa Malde, Michael D. Scott, Jan Sebastian, William F. Smith, Christine May Sturgeon, Michael Whittington, and Powell T. Wood.

Mail-in ballots go out December 24 and voters must return them by January 15, 2013.

Once elected, the charter commission will have 180 days (six months) to draft a home rule charter for Salida. After that, citizens will vote again to either accept or deny the charter.

Note: Home rule is the power of a local city or county to set up its own system of self-government without receiving a charter from the state. ... The authority to act in local affairs is transferred from state law to a local charter, adopted and, as need be amended, by the voters through referendum. Source: USLegal.com
